After 1/31/04 services are sold on a first-come, first-sold basis. If for any reason bid is unsuccessful, the check will be returned to bidder uncashed.

Once this bid is accepted and the bid check is cashed, Mare Owner shall have a legal financial obligation to PPEA until check has cleared and funds are received by PPEA. In the event a check is returned unpaid for any reason, PPEA reserves the right to add bank fees and costs.

PPEA shall notify stallion owner with the name and contact information of the purchasing mare owner when the above stud service is sold and paid for. Upon receipt of this information from PPEA, the participating stallion owner has agreed to promptly execute an appropriate breeding contract with the purchasing mare owner. Mare Owner and Stallion Owner shall schedule and make all arrangements for the actual breeding between them.
